Celebrate Rotary Foundation Month



November is Rotary Foundation Month. It all began in 1917 when then RI President Arch Klumph announced the acceptance of endowments for doing good in the world – The Rotary Foundation was born! Contributions took off in 1947 in memory of our founder Paul Harris. Although The Rotary Foundation originally sponsored only educational programs, it added humanitarian programs in the late 1960s and has continued to evolve with the addition of our famous PolioPlus program to our Permanent Fund, the Rotary Centers for International Studies and, finally, the Future Vision Plan.

Our 3-year Future Vision pilot took effect on 1 July. The pilot is intended to teach us what is good – or bad – in our plan, so that we can correct it, as the Future Vision Plan is here to stay.

However, The Rotary Foundation's Future Vision Plan is much more than just a plan for the Foundation. Rotary International's Strategic Plan is a parallel plan which, to a large extent, joins and supplements our plan. We are too small an organization for two plans of this magnitude – they shall have to merge. Not necessarily tomorrow, but sometime after 2017 when The Rotary Foundation celebrates its 100th anniversary. If I were to target a year for this merger, I would pick 2025 – the year when our Permanent Fund is expected to reach USD1,000,000,000 (one billion!).

CHANGES OT THE CLUB CONSTITUTION AND BYLAWS:

Here are the main changes to the Club Constitution and Club Bylaws as set out by Rotary International in the new RI Manual of Procedures released this week.

A. CLUB CONSTITUTION

Article 5: Five Avenues of Service

5. New Generations Service, the fifth Avenue of Service, recognizes the positive change implemented by youth and young adults through leadership development activities, involvement in community and international service projects, and exchange programs that enrich and foster world peace and cultural understanding.

Section 3 – Excused Absences. A member's absence shall be excused if

- (a) the absence complies with the conditions and under circumstances approved by the board. The board may excuse a member's absence for reasons which it considers to be good and sufficient. Such excused absences shall not extend for longer than twelve months.
- (b) the age of the member is 65 and above and the aggregate of the member's years of age and years of membership in one or more clubs is 85 years or more and the member has notified the club secretary in writing of the member's desire to be excused from attendance and the board has approved.

There are few very small changes but that is it for the Constitution as far as I can see.

B. CLUB BYLAWS

Article 8 Four Avenues of Service

The Four Avenues of Service are the philosophical and practical framework for the work of this Rotary club. They are Club Service, Vocational Service, Community Service, International Service, and New Generations Service. This club will be active in each of the Four Avenues of Service.

Article 9 Committees

Club committees are charged with carrying out the annual and long-range strategic goals of the club based on the four Avenues of Service. The president-elect, president, and immediate past president should work together to ensure continuity of leadership and succession planning. When feasible, committee members should be appointed to the same committee for three years to ensure consistency. The president-elect is responsible for appointing committee members to fill vacancies, appointing committee chairs, and conducting planning meetings prior to the start of the year in office. It is recommended that the chair have previous experience as a member of the committee. Standing committees should be appointed as follows:

Article 10 Duties of Committees

The duties of all committees shall be established and reviewed by the president for his or her year. In declaring the duties of each, the president shall reference to appropriate RI materials. The service projects committee will consider the Avenues of Service Vocational Service, Community Service, and International Service when developing plans for the year.

Article 11 Leave of Absence

Upon written application to the board, setting forth good and sufficient cause, leave of absence may be granted excusing a member from attending the meetings of the club for a specified length of time for no longer than twelve (12) months.

Again that is all apart from some very minor changes.
